**NOTICE OF MANDATORY WATER CONSERVATION MEASURES**

Dear ACWWA Customer,

As we prepare for the upcoming irrigation season, ACWWA, your water provider, is evaluating our water resources and executing plans to ensure responsible water usage and a reliable supply. ACWWA takes the safety of its water supply seriously and is taking proactive measures to meet new drinking water regulations before they are fully required. Managing ACWWA's water supply is a key aspect of providing safe and reliable water to all customers. For this reason, ACWWA's Board of Directors authorized implementing **Stage 2 Water Conservation Measures beginning May 1, 2025.**

Stage 2 Water Conservation Measures are mandatory and are designed to reduce inefficient water use. **Customers are required to adhere to the following restrictions:**

- Irrigation of landscaped areas with in-ground sprinklers or hose-end sprinklers is limited to a maximum of three days per week. Watering schedule is included below.
- Outdoor watering is prohibited between 10 am and 6 pm.
- Hand watering of trees, shrubs, flowers, and vegetable gardens is allowed any time, but avoiding the hottest times of the day is recommended.
- Wasteful water usage is prohibited, including excess water running to street gutters and neglecting to repair leaks.

**Any customer that violates the Stage 2 Measures will be subject to additional charges and/or conditions of service.**

Customers that are establishing new turf can contact ACWWA ([contactus@acwwa.com](mailto:contactus@acwwa.com)) for a new turf variance that can be issued for a period of 30 days. Customers should avoid planting new turf from June 1<sup>st</sup> to August 30<sup>th</sup>.

## 2025 Watering Calendar

ACWWA is implementing a separate schedule for its commercial customers, which include multi-family properties, HOAs, and commercial properties. The separate schedule is based on location and is split into two different zones. Commercial Zone 1 is located south of Arapahoe Road and west of Jordan Road. Commercial Zone 2 captures all commercial customers located north of Arapahoe Road and east of Jordan Road. A map depicting Zones 1 and 2 is included.
